Q1 Results Herhofer Space Group

We delivered first step of changing our financial capitals and assets structure by dropping Great British Pound end of life policy in our business and onboarding Herhofer Net Worth as part of our invention, Herhofer Net Worth Planetary, Space and Interstellar Currency Referencing Service using SCRAM Herhofer Ent Worth and FCA Herhofer Net Worth.

Our planning delivered Q1 2024 expected progress of:

- opening shares to sale
- published shares account to be provided for sales and interest
- Launched Transition HNW EQU -> HNW Banking SCRAM Financial Network and Uk payments BACS, FPS, CHAPS
- Herhofer Space Bank is registered for audit purposes in Wandsworth Court Case LOPP2128, all our assets, patent net worth estimate in my final speech.
- We won 6 of six court cases and blocked one Money Judgement Order wrong recipient
- Because, we dropped Great British Pound end of service in our total payments, the business-as-usual payments are blocked as expected by our Business Plan. We expected the consequence of court cases avalanche, prepared for the avalanche we won 6 court cases one of them in Westminster Magistrates' Criminal Court, SUMMONS 1089574, ACCOUNT 68580270, SCRAM Herhofer Financial Network is different banking system of Herhofer Stargate Celleste Space Economic Zone and Space Jurisdiction serving Herhofer Net Worth only, our very only currency used in Celleste Space Zone Short Name. Bank of England is the only bank serving Great British Pound.
- Onboarding Herhofer Net Worth as expected business as usual payments are blocked off the unknown currency rejected by banks but accepted in court cases rulings and HMRC.
- We received highest appreciation by HSBC who provided us Free Mortgage before case end.
- We found EQUIVO collections agency gross misconduct, try avoid court and orders, compliance of cases:

- EQUIVO ISSUED wrong recipient money judgment order for £24k defender is Mr Arnol Evode Bah court judgement order HO1WT365 £24,689.90, and wrong recipient of court case Diana Milu vs Lorenz Herhofer case KO1WT288, claiming £26,000 losses. I won the case, Diana Milu was evicted by police not paying council tax, consequently London Borough of Hammersmith and Fulham launched Westminster Magistrates Criminal Court SUMMONS 1089574 for unpaid council tax bill, I also won the case.
- EQUIVO rejected letter with payment returning it undelivered by royal mail tracking service "Recipient moved from the address", confirmation is provided to the court.
- EQUIVO declared wrong and false address in court case LOPP2128 in "STATEMENT OF TRUST", we immediately revoked EUIVO lawyer court case rights and evicted their lawyer from the case.
- EQUIVO lost court case LOPP2128 defending HSBC interests and send me invoice of £1,8k. It is familiar to anybody case loser is paying all fines, fees and charges. I have final court ruling does not contain wording "Defender must pay claimant's court fees". Missing this statement, confirms I am case winner, invoiced fee case LOPP2128.
- EQUIVO launched reverse of already paid and ruled court case, I have court confirmation "paid", try revert paid check together with Caunce O'Hara who accepted payment than rejected 6 months later, case K9BA6G6J
- EQUIVO wanted reverse 10 months later after payment is confirmed by court ruling "Paid" case
- Companies House
  - Companies House Register unpaid fine late filling £750, I objected the case LOBP299F
  - Companies House have bug in their website allowed more than one filing submitted for the same period. Another bug is the letters I continue receive late filing and fill again for second time.
    - Companies house second bug in their website, they strike Herhofer Space Group automatically, in case Herhofer Space Group h e VAT reg, Credit Card with HSBC, bank account in HSBC and spendings. Default running business is crime in UK

Expecting court cases and defending properly without harming the business launched court cases, not responding in reverse with counter court cases, we assume we are on the right way to defend the right of Celleste Space Zone, Celleste Space Zone Central Bank – Herhofer Space Bank and Celleste Space Zone Currency Herhofer Net Worth.

Our perception is the defence of Bank of England and Great British Pound is empowered in correct and lawful way to detour false currencies like crypto who are alternative.

Presenting ourselves in the best of our business we earned number of positive feedback from HSBC:

- World Elite Membership
- More than £430,000 in mortgage, credits and credit cards,
- Business loans and credit lines
- Agreement how much I can bear with my income
  - than £30,000, after that boundary HSBC launched Court Case LOPP2128 where we Herhofer Space Group Board designed the case for audit purposes and defended the total of Herhofer Stargate Celleste Space Economic Zone and Space Jurisdiction, designing all requirements to audit the court case in the spotlight of:
    - Herhofer Stargate Celleste Space Economic Zone and Space Jurisdiction
    - Herhofer Space Bank Structure
    - Herhofer Net Worth Planetary, Space and Interstellar Currency Referencing Service
    - Proof Of Concepts in banking and interstellar financial operations
    - Money Concept Financial Conduct Authority Herhofer Net Worth
    - Financial Conduct Authority Herhofer Space Bank not require Registration, a Credit Union Type with Variation of Permissions using own funds only, operations in UK only, FCA Handbook design and HMRC exempt registration bill payments, spendings and payroll

    - Estimated Herhofer Net Worth of 3 patents added in final speech, net worth in trillions in space industry

  - Pay in Great British Pound

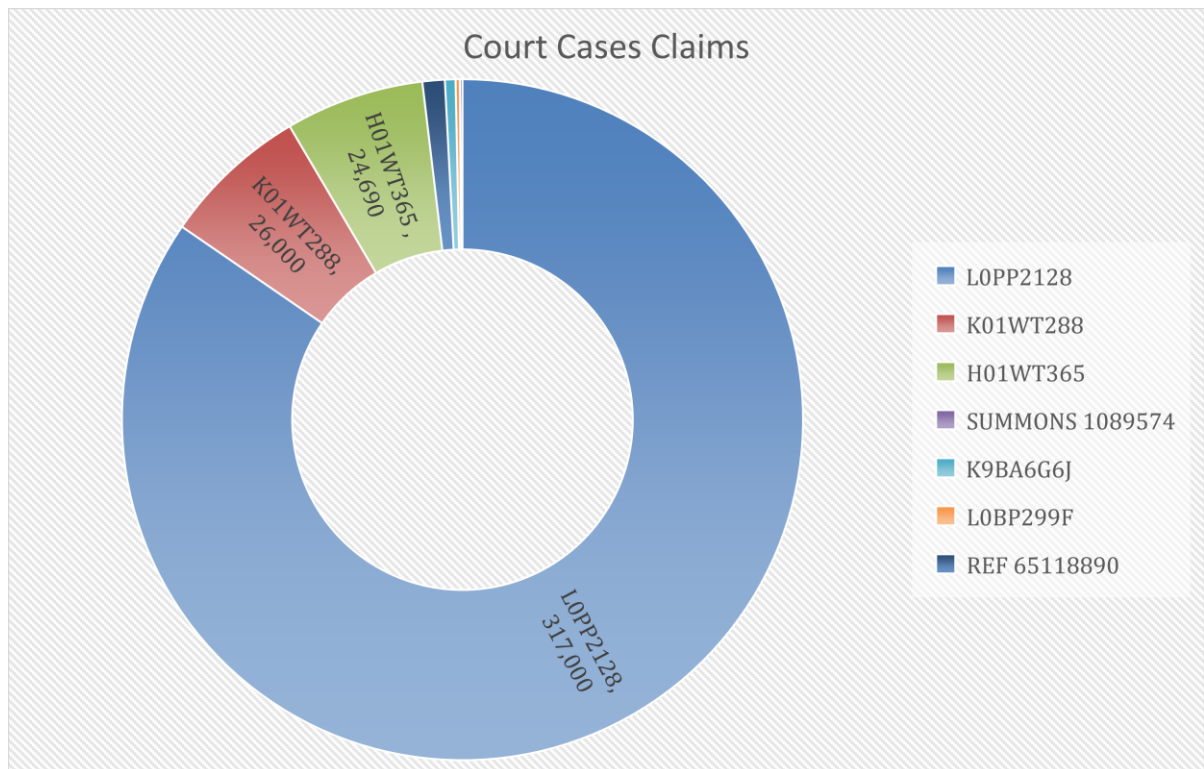

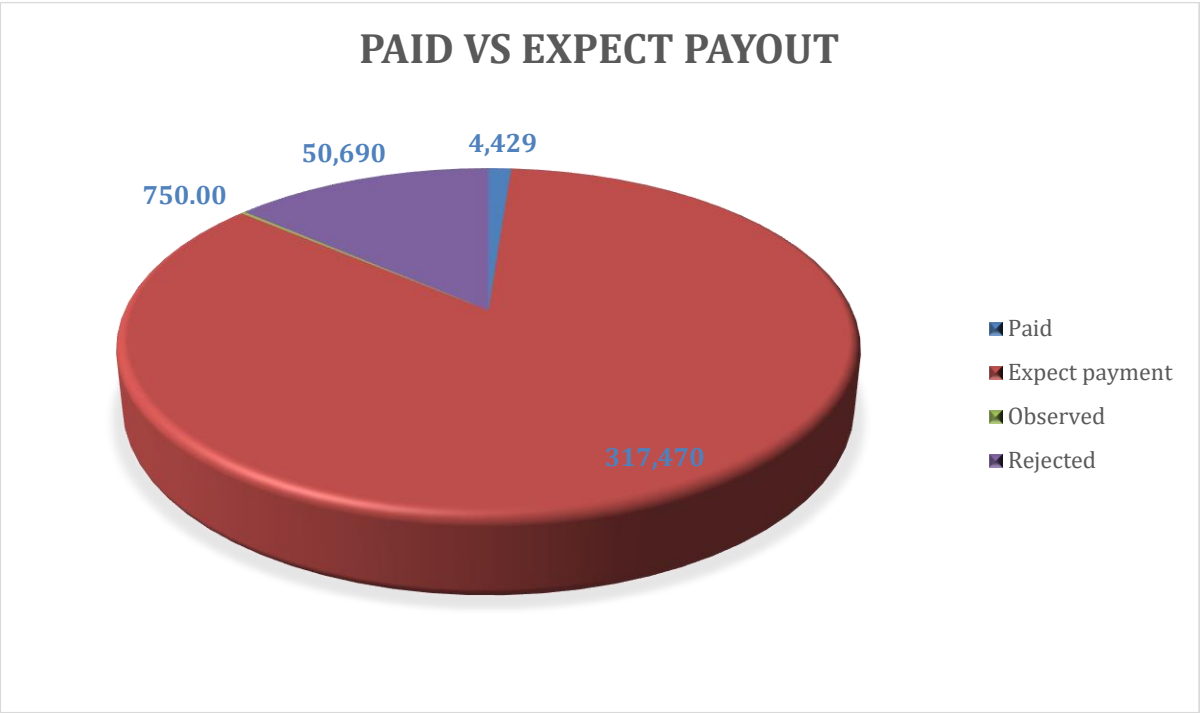
What is Next:

- Repay HSBC totals of more than H430,000
- Accomplish cases we won to pay totals and totals of our creditors
- Register Herhofer Space Research Institute Bank Ltd
- Authorize Herhofer Space Research Institute Bank as obligated by UK Banking standards, Law and Financial Conduct Authority
- Register Herhofer Space University and use sensitive words University and Institute we prove we do research and awarded 3 PhD for research.
- Launch Herhofer Space University accept students by 2026 when we planned our orbital satellites mobile telecom and banking private network to be delivered and students see real live example how to build space business themselves.
- For the purpose of Herhofer Space University we engaged and we have planned appointment in Q3 when we expect to deliver salary payment to our Director Education at Herhofer Space Group Board Astrid Herhofer, PhD
- We expect two more cases we consider forged and fraud

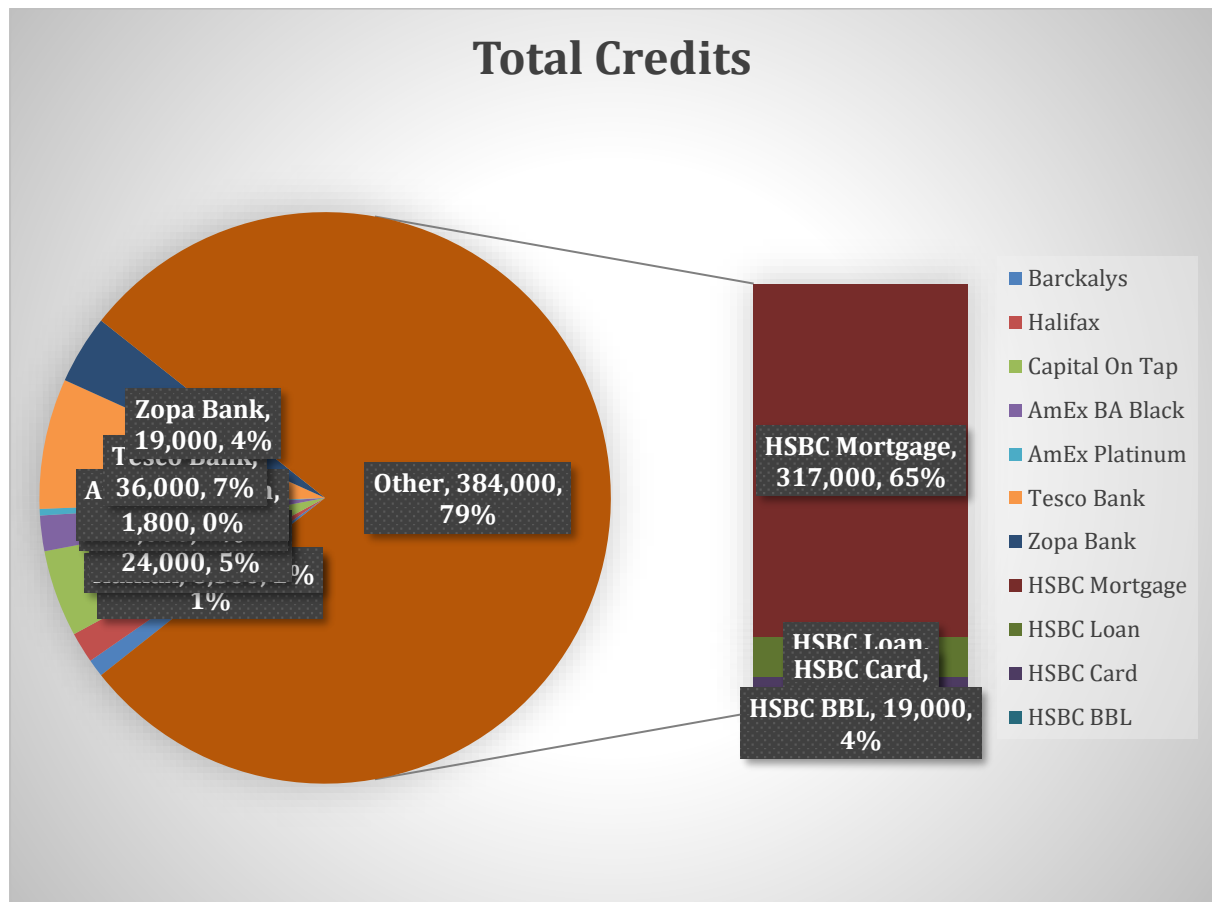

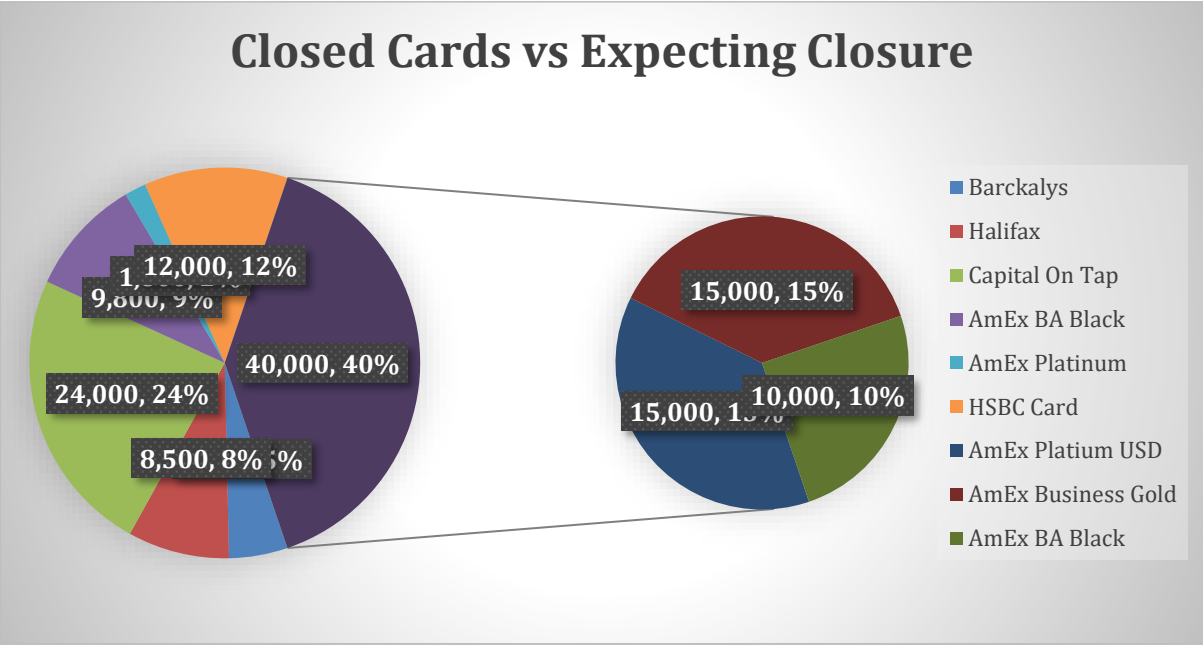
