Dear Wandsworth County Court,

I owe nothing to the person, Diana Milu tenancy was terminated and Diana Milu received the termination notice twice. I found she is sex worker not disclosed in her application, not presenting a job contract after the initial period. We spoke over the phone including she must sign her words after the call in writing, what we agreed and we spoke on the phone. After Diana Milu rejected signing her words I sent a final termination notice to leave the flat, the flat is my sole ownership. During our conversations, I never mentioned Nikolay Yakov nor Elena Yakova. I am unaware how she did find these names as the contract and negotiations had been signed with me and my own bank account. I confirmed this flat is my sole ownership in the contract.

Diana Milu told me she is abroad but the number is missing +44 when the caller is calling an overseas UK number, she rejected further conversations in any kind after final termination notice. I came once to talk to Diana Milu about her tenancy, the door was locked without any response, I sent Diana Milu an email clarifying not signing our phone conversation and not entering in contact in any way, Diana Milu must leave the property.

After a week I sent the cleaner lady to clean the flat, I thought she left and the cleaning lady will prepare the flat for the next tenant, also return her the deposit. The cleaning lady found two women living together instead of Diana Milu only as per the contract. We exchanged whatsapp text messages transmitted via cleaning lady and she transmitted my request to Diana Milu asking her to leave ASAP after final termination notice was served. Cleaner lady wrote to her - if she leaves, I will return the full amount, in case I must evict her I cannot refund because of the expenses and onboarded one more Director.

When I arrived last time when she was evicted, she again refused to talk and she called the police. At that point, I told the policeman to contact Emma West Met Police Counter Terrorism, my contact point in the police. I found out that Diana Milu is sex worker, and her solicitor is from porn industry. His website was blocked by my mobile phone Three filter. I do not owe the offender Diana Milu any penny for her fraudulent behaviour when I served her termination notice twice and she rejected any contact. In addition I onboarded Director Counter Terrorism to protect myself from a tenant who took hostage my own flat, impossible to evict for years.

WITH THE POLICE ARRIVED RESPONDING ON HER CALL, WE AGREED SHE MUST RETURN THE KEY FROM THE PROPERTY AND THE FRONT GATE,

SHE STOLE MY KEYS FROM MY FLAT AND FRONT GATE, MARTIN PENDERGAST PROPERTY MANAGER REFUSE TALKING ME, NOT ISSUING ME NEW KAY AND THE ISSUE DIANA MILU CAUSE ME LEAD TO PERMANENTLY STOLEN KEYS FROM THE FRONT GATE, IN ADDITION I REPLACED FLAT DOOR LOCKERS.

Dear Wandsworth County Court, If you need further attention, please get in touch Emma West, I cannot handle issues with porn and sex industry violence and law breaches providing porn industry wording like "Working HR in Winter Wonderland", the meaning is I am sexworker running home and I "sell snow". Please read the slang dictionary, I did after Diana Milu didn't get in contact. I did believe she is Working for the famous Winter Wonderland German Winter fest. Diana Milu lied about her job discovered later when she rejected any conversations.

Since that time, I onboarded Emma West Met Police Counter Terrorism MI5 as

Director Planetary, Space and Interstellar Counter Terrorism At Herhofer Space Group, A trading name of Galactic Services Space Ltd.

Emma West is aware of the full case since the beginning and all my further works, all my affairs are public.

No harassment, two termination notices served and one conversation, Diana Milu rejected further relationship improvement.

No trespassing, I am the flat owner and I have Keys from the gate and the flat in case the tenant will steal the keys as Diana Milu did.

I ENTERED IN THE POSSESSION ON THE NEXT DAY LAUNCH TIME, THE KEYS WASN'T ON THE WHITE TABLE IN THE LIVING ROOM, RECORDED ON THE POLICE BODYCAM AGREEMENT.

I was SUMMONED by the London Borough Of Hammersmith and Fulham to pay totals of £763.77, not paying for three months, Diana Milu stopped paying my bills totalling £1148 council tax, electricity and water.

I paid summons using my own money Herhofer Net Worth and I won the case, no convictions.

Martin Pendergast invoice contains additional £4600 for solicitor expenses, I rejected payment under missing court ruling and convictions of lost case.

My currency is FCA and HMRC AML Regulated, at present I don't have any issues paying any amount.

Reasons to terminate the contract:

- Diana Milu lied about her job, later discovered sex worker
- Diana Milu rejected communication
- Diana Milu lawyer is from porn industry Adam Bernard
- Diana Milu didn't get in touch to improve our relationships and rejected sign our verbal agreement
- Diana Milu stopped pay my flat bills for three months, forcing London Borough Of Hammersmith and Fulham Summon me in Westminster Magistrates' Court not paying Council Tax £763.77
- Martin Pendergast replaced Entrance Gate after I notified him Diana Milu stole entrance gate key and she is from porn industry adding £4600 to my bill
- Counterclaim demand, total of:
  - counterclaim demand £12,837 of bills,
  - counterclaim demand £10,000 charge of corrupting my good reputation of landlord offending me with court case and reputation damages and losses of tenants stealing my keys.
