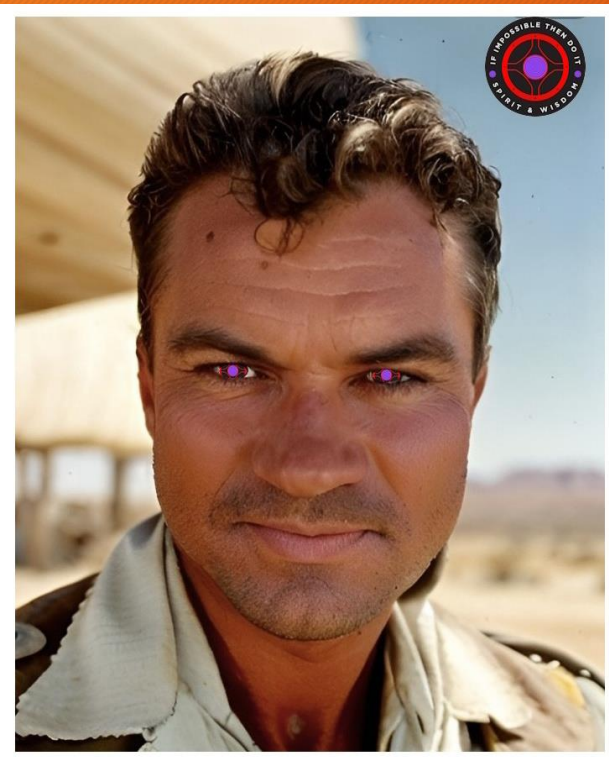
Summary - Herhofer Space Group
