I am writing to you to inform you, LONDON BOROUGH OF HAMMERSMITH AND FULHAM do not respond on the mentioned email addresses on the back of the summon counciltax@lbhf.gov.uk and recover@lbhf.gov.uk **MORE THAN 15 (FIFTEEN) DAYS**, **I wrote twice following the advice to talk first with them**, now I am sending official request to break the forged summon as it duplicated another ruled case of Her Majesty Courts and Tribunals Services, The Civil National Business Centre, 4th floor St Katherine's House, 21-27 St Katherine's Street, Northampton, NN1 2LH, CASE Number K9BA6G6J, they are aware of this case, including my below explanation. In the court ruling my name is identified as Lorenz Herhofer, my currency Herhofer Net Worth identified as lawful payment currency Financial Conduct Authority Regulated and accepted payment, arrears due account settled, default notice removed from credit agencies.
